# Treasurer Report, Income & Expense statement: Bud Havens

Treasurer's report & Income/Expense statement through 9/30/2023 were distributed to all trustees for review.

- As of 10/31/2023: Total assets - \$837,512.

 As of 10/31/2023 all expense areas except Irrigation Maintenance and Trash Collection are

under budget – Irrigation due to repairs after lightening damage (as of 11/10 this area is underbudget due to deposit of the insurance check covering the lightening damage, and will remain under budget with the remaining expense being system shutdown), Trash due to WM fee increases (which will be erased by lower fees for new contract with Stanley and be slightly underbudget in December).

 We have also received a payment for the insurance deductible for the Lacey/Gardenia accident in 2022, this has been applied to miscellaneous income for this year.

<u>2023 Budget</u>- no issues, approximately \$ 30,000 under budget.

- Three maintenance fees were overdue in October –
- 2 accounts are in accelerated assessment with liens filed; In accordance with our bylaws, we are working with our lawyer (who is also our collection agent) to further accelerate these 2 assessments.
