There can be no more than three (3) occupants residing in any Home.”*

*“F. Visiting Children (1) Children under the age of nineteen (19) visiting a member of the Association and/or a resident shall be restricted to a three (3) week cumulative visitation per calendar year. [As amended by the Board of Trustees, 6/14/2016]*
